MEMBERSHIP AGREEMENT

This Membership Agreement is between the RACQUET CLUB OF IRVINE and the undersigned MEMBER.

A. MEMBER understands and agrees:

1. To be bound by the RACQUET CLUB OF IRVINE's Rules, Regulations & Conditions of Membership (the "Rules") as now in effect and as may be amended or supplemented from time-to-time at the RACQUET CLUB OF IRVINE's discretion, and that MEMBER has been emailed a copy of the Rules, including Article Two, pertaining to Membership Termination, and grounds for expulsion of a member.

2. When applicable, a \$25 single and a \$40 couple/family monthly hospitality fee is billed quarterly for those members who do not reach the monthly spending limit for their membership.

3. To be bound by the RACQUET CLUB OF IRVINE's Assumption of Risk and Release of Liability Agreement, which is: The MEMBER assumes all responsibility and risk derived from use of the premises and all facilities pursuant to this license, including but not limited to, the use of the undersigned members of the undersigned's immediate family and guest of the undersigned, and further agrees to hold the RACQUET CLUB OF IRVINE, its agents, servants and employees free and harmless from, and indemnify RACQUET CLUB OF IRVINE and them from damages or liability including, but not limited to, attorney fees and costs for any injury to person or property arising as a result of the premises and facilities as aforesaid. The RACQUET CLUB OF IRVINE is not and shall not be responsible for any injury, damage, or loss by a member, or his/her family, or guest on or off the RACQUET CLUB OF IRVINE premises while participating in any club activity, even if such losses caused by the acts or omissions of other members, staff, or any other person.

4. To pay monthly dues, annual/initiation fees, and charges for goods and services upon receipt of a RACQUET CLUB OF IRVINE's monthly invoice via Automatic Debit on your credit card provided. The dues shall be initially that amount indicated below but shall be subject to increases pursuant to Article One, Section 4 of the Rules.

5. That all annual/initiation fees, and pre-paid monthly dues are non-refundable.

6. That all memberships are non-transferable, and can be terminated at any time at the discretion of management, in which case a MEMBER's liability for future monthly dues ceases.

I agree to the terms of this membership agreement with RACQUET CLUB OF IRVINE, including the Rules, Regulations & Conditions of Membership. This Agreement will be on a month-to-month basis. I understand my membership dues are subject to change with notice. I understand that canceling memberships require A 30-DAY WRITTEN CANCELLATION NOTICE PRIOR TO THE FIRST DAY OF THE MONTH.
